The Golden Leaf Festival is making plans for the 27th Annual Golden Leaf Festival. Saturday, September 26, 2009. The hours will be 9:00am to 5:30pm. The location is beautiful Smith-Haven Park in the heart of downtown Mullins, South Carolina. Vendors have the option to move to the Party After Dark site. Party After Dark hours ate 7:00pm - 10:00pm. The festival will be a one day event.

If you are interested in being a food vendor at the September 26, 2009 Festival, please submit your application to Golden Leaf Festival, PO Box 691, Mullins, SC 29574. If you have questions you may call the Festival Office at (843) 464-5200. First completed and returned applications with fee attached will receive priority. Space is limited. If you would like confirmation that your application was received, please send a self-addressed stamped envelope or put your e-mail address on this form.

**INSTRUCTIONS: LeBleu Bottled Water is the official Water of the GLF. No other bottled water is allowed to be sold. Vendors may contact the GLF Board if they would like to purchase water to sell.**

1. Food vendors will be responsible for complying with ALL HEALTH DEPARTMENT REGULATIONS, and for collecting and reporting all applicable taxes. A South Carolina Tax Identification number is required by state law.
2. Food vendors must be in place by 9:00am and remain open until 5:30pm. All vehicles must be unloaded and moved from the park to designated parking areas by 8:30am. Vehicles may return to load after 5:30pm.
3. The Golden Leaf Festival assumes no liability for loss or damage to property.
4. Spaces are not more than 15 feet and tents over 15 feet, including tent stakes will not be accepted. Vertical guards must be placed at each tent stake.
5. Water and electricity are available. Check with the Committee.

The required fee is \$150.00. In the event that the Golden Leaf Festival determines that the Festival cannot setup, 50% of the paid fee will be refunded. A rain site is available. Food vendors are instructed to report to Smith-Haven Park if the weather is inclement to receive instructions as to the rain site. No refund will be made to vendors who choose not to setup at the rain site.
