Minutes City Council Meeting Tuesday, October 9, 2018

The regular monthly meeting of the Mullins City Council was held Tuesday, October 9, 2018 at 6:00 P.M. in the Raymond Pridgen Auditorium. 1. Call Meeting To Order & Welcome: Mayor McMillan called the meeting to order and welcomed all present.

Margaret Carroll led everyone in the Pledge of Allegiance.

Invocation: The invocation was given by Council Member Robert Woodbury.

Mayor Pro Tem Phillips made a motion to approve the Consent Agenda. Council Member Woodbury seconded the motion.

5. Old Business:

(a) Francis Marion Sign

The total cost of moving and installing the Francis Marion sign would cost \$10,880.00. Street Supervisor Tarus Gilchrist stated the property where the current sign is located is owned by the property owners. Gilchrist also stated part of the sign is in the right way and Harold Coleman from DOT would need to be contacted. Sanders made a motion to table the sign until Holly Jackson contacts the property owners. Phillips seconded the motion.

Council Member Kitchen made a motion to accept RESOLUTION #18-009, RESOLUTION COMMITTING THE CITY OF MULLINS TO PROVIDING A LOCAL MATCH FOR A MUNICPAL ASSOCIATION OF SOUTH CAROLINA HOMETOWN ECONOMIC DEVELOPMENT GRANT AND FOLLOWING ITS PROCURMENT POLICY WHEN SECURING SERVICES AND PRODUCTS WITH GRANT FUNDS. Council Member Davis seconded the motion.

(c) Domestic Violence Awareness Month

Mayor McMillan recognized Ronette Genwright with Pee Dee Community Action. Genwright stated October is Domestic Violence Month. The statistics for 17-18 were 24 family victims. On an average the victim usually spends an average of 11 nights in a shelter. Genwright stated the Bad Dog Coffee Shop would be having a speakout program on October 18th from 6-8 PM. Council was invited.

(d) Enterprise Fleet Management

Sanders stated it was a recommendation from the Finance Committee to proceed with Enterprise Fleet Management. Chief Bethea stated the fleet will be replacing 6-7 Crown Vics with Dodge Durango's. The oldest vehicle in the fleet is a 2004 Crown Victoria with 200,000 miles on it.

Council Member Sanders made a motion to move forward with the leasing from Enterprise. Council Member Sanders seconded the motion.

The City will be offering Health Screenings to employees.

Council Member Woodbury stated during Hurricane Florence there was a strong need for the Fire Department to stand in until various counties came in to help. Chief Stetson has a team together to get certified for Swift Water Rescue. The equipment was purchased locally and will arrive tomorrow. The team will go to training next week.

8. Comments:

(a) Sylvia Cribb Gray – Re: Drainage

Mayor McMillan recognized Sylvia Cribb Gray. Gray stated her concerns for the drainage on Barnes & Valentine Street and trash pick up. Gray stated no one has cleaned out the drainage. Gray also stated she was out of her house for over a year after Hurricane Matthew. Gilchrist stated the pipes on those streets are clear. The issue comes from the County. Gilchrist also stated trash pickups are behind but should be back to normal by the end of the week. The landfill just re-opened. Sanders advised Ms. Gray to see her County Councilman Allen Floyd concerning her drainage issues. She also advised her to attend a County Council Meeting.

Council Member Davis congratulated the Street Department for their dedication and hard work during Hurricane Florence.

Mayor McMillan recognized Dale Smith - 109 Lake Street. Ms. Smith stated her house is the only one on Lake Street that floods. The sides of the road are washed away. Trash is still there from the hurricane.

Mayor McMillan recognized Joy Richardson / Tussie Mussie Garden Club. Mrs. Richardson stated her concerns for Mayers/Norton/Cederdale Cemeteries. Richardson asked Council to put together a committee for the upkeep of the cemeteries. Richardson asked the city to search for grants for the cemeteries. Many people look at those things when trying to relocate to a new town. Mayor McMillan stated city employees are not to touch any of the tombstones.

Sanders noted the flower pots on Main Street. Gilchrist stated the irrigation does not work and hasn't in years. Sanders asked Chief Stetson if the Fire Department could water those plants.

Council Member Davis stated Homecoming is next Thursday at 4:30.

Council Member Woodbury stated there would be a Gospel Fest at Smith-Haven on October 13th from 10-2 PM. This is a community event.

Council Member Kitchen stated the Lions Club Run for Sight would also be October 13th.
