BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MULLINS

here assembled on this 29th day of September 2022, that the Mullins City Council hereby commits to provide a local cash-in-kind match of at least \$1,250.00, which equals the minimum five percent local match required by the Municipal Association of South Carolina, to support the City of Mullins application for a \$25,000.00 Hometown Economic Development Grant. These grant and local matching funds will be used for a Multi-Use Outdoor Market place and Park.

BE IT FURTHER RESOLVED that the Council will follow its procurement policy adopted in accordance with SC Code of Laws Section 11-35-50 when securing all services and products purchased with funds awarded from a Hometown Economic Development Grant.
