Some exercise material is intended for the exclusive use of exercise planners, facilitators, and evaluators, but players may view other materials that are necessary to their performance. All exercise participants may view the SitMan.

The Mullins Fire Department, in partnership with Marion City Fire, MAN COUNTY EMS, Marion City Fire, Marion City Police, Marion County Emergency Management, Mullins Police Department, Marion County Sherrif, Salvation Army, Red Cross, School District bus, SLED, SCEMD, MUSC Hospital, AIR REACH, 911 Emergency. will be conducting training on May 22 both am and pm lecture classes. Classes to include TECC, Active Threat, MARCH, Stop the Bleed.

Afternoon of the 22nd will be a dry run for the scenarios.

May 23 will see a full scale scenario to include LEO control of the hot zone, triage/treat/transport multiple patients, secure the scene and maintain chain of custody.

Exercise Structure

This exercise will be a multimedia, facilitated exercise. Players will participate in the following scenario:

Module 1: Active Threat with Warm Zone Operations

The module begins with a real-world simulation that summarizes key events occurring within that time period. After the updates, participants review the situation and engage in functional demonstrations of appropriate TECC strategy and tactics. For this exercise, the participants are broken into groups that would mimic a LEO/EMS/Fire department response assignment to the exercise scenarios.

After these functional group discussions, participants will engage in a moderated plenary discussion in which a spokesperson from each group will present a synopsis of the group's actions, based on the scenario.

Exercise Guidelines

- This exercise will be held in an open, no-fault environment wherein capabilities, plans, systems, and processes will be evaluated. Varying viewpoints, even disagreements, are expected.
- Respond to the scenario using your knowledge of current plans and capabilities (i.e., you may use only existing assets) and insights derived from your training.
- Decisions are not precedent setting and may not reflect your jurisdiction's/ organization's final position on a given issue. This exercise is an opportunity to discuss and present multiple options and possible solutions.
- Issue identification is not as valuable as suggestions and recommended actions that could improve fire/rescue efforts. Problem-solving efforts should be the focus.
- The assumption is that the exercise scenario is plausible and events occur as they are presented. All players will receive information at the same time.

Exercise Evaluation

Evaluation of the exercise is based on the exercise objectives and aligned capabilities, capability targets, and critical tasks, which are documented in Exercise Evaluation Guides (EEGs). Evaluators have EEGs for each of their assigned areas. Additionally, players will be asked to complete participant feedback forms. These documents, coupled with facilitator observations and notes, will be used to evaluate the exercise and compile the After-Action Report (AAR)/Improvement Plan (IP)
