Council Member Kitchen stated the Police Department now has three (3) certified officers.

Council Member Kitchen talked about the Buddy System which would give officers a \$1,000.00 bonus \$500.00 at the beginning and \$500.00 at the end of the year for recruiting new officers. This would begin on July 1<sup>st</sup>. Council Member Kitchen made a motion to accept. Council Member Brewton-Pompey seconded the motion. Mayor Pro Tem Wilson abstained.

Captain Mostowski explained the time line for the City taking back night shift has been pushed back due to the FTO program. The entire process takes eight (8) weeks.
