Mayor Pro Tem Carolyn Wilson stated the landscape for the Park Street Gym is underway at this time. The Park Street Gym renovations will be complete in the coming weeks. Basketball games have been held at Marion-Mullins Christian School and Palmetto.

Mayor Woodbury stated the report from the Special Events Coordinator Oglaretta White was included in the packet. The Building Code Department stated 18 permits have been pulled this past month.

Mayor Woodbury stated the City has recouped \$35,000.00 with the cooperation with Data Max.
