GENERAL INFORMATION

1. All BARBECUE COOK-OFF PARTICIPANTS MUST be in place by no later than 3:00 pm. Volunteers will be at the cooking area not later than 10:00 am on the day of the event to direct you to your designated cooking site. At least one representative from each team must attend the Mandatory Cook's Meeting at 2:30 pm. Meat will be distributed as early as possible (plan for 1:00 p.m. distribution), but no later than the end of the Cook's Meeting. All vehicles must be unloaded and moved from the cooking area to designated parking areas by 4:45pm on Friday and may return to load after 2:00 pm on Saturday.
2. The BBQ Contest is sanctioned by the South Carolina Barbecue Association, and will abide by SCBA Rules & Guidelines.
3. An entry fee of \$250.00 (which must be submitted along with the team application) is required from each team to enter this contest. The event will be providing each entrant approximately 80 lbs. of pork butts, sampling plates, napkins and setups. Any questions concerning the BBQ Contest should be directed to the BBQ Contest Event Coordinator who will make all final decisions.
4. **Friday night from 7:00 – 9:00 pm there will be a MANDATORY “Anything Butt” competition. All teams are expected to participate.** Each team shall prepare and serve an entry of their choice which will be judged by a panel of Celebrity Judges using a very similar blind judging method as you have experienced with SCBA Sanctioned events. Blind judging containers will be delivered to each team's cook site not later than 6:00 p.m. If you have not received a container, send a team member to see the Event Coordinator. When you bring your entry to the judging area, the containers shall contain only your entry - no garnish, just your Anything Butt entry. Each team shall provide all ingredients for their chosen dish, but the event shall provide sampling plates, napkins and setups. Please plan to have enough of your entry prepared by 7:00 pm to provide approximately 100 samples to the public and 10 samples for the Celebrity Panel. **Your submission for judging and the product you serve the public must be the same. Failure of a team to participate will result in disqualification.**
5. The Friday Night “Anything Butt” contest will award a cash prize of \$500.00 to the winner, \$400.00 to the First Runner-up; \$300.00 for 3rd Place; \$200.00 for 4th Place and \$100.00 to 5th Place. We are investing in a significant prize purse (total of \$1,500.00) just for the Anything Butt portion of this event and each team will be expected to produce an entry that showcases their ability to produce a quality product in addition to great pork barbecue.
6. All entries must be cooked on the official BBQ Contest grounds. However, your entry for the “Anything Butt” may be prepped off-site, provided you do final preparations, at least some cooking and assembly of your entry on-site.
7. With the exception of the Friday Night “Anything Butt” contest, all BBQ Contest entries are limited to meats that are provided by the festival.

8. Contestants may season or prepare meats as the contestant sees fit.
9. This is a Barbecue event. Cooking can be done on a charcoal, wood, or gas fired device. **Meats that are boiled (only) or fried (only) will not be accepted.**
10. The BBQ Contestant is responsible for observing accepted and prudent temperature and sanitary requirements as well as a method for maintaining safe temperatures for meats and any side dishes. Food product submitted for judging which is undercooked, or raw will be disqualified immediately.
11. Only meat provided to the teams by the event shall be submitted for judging – teams may not provide their own meat for the contest. All teams will receive meat from the same source and as like in quality as is possible. **All meat provided by the event to the teams must be cooked for distribution to the public. All meat is the property of the event and the Golden Leaf Festival.**
10. **Quiet time will be observed from 11:00 p.m. on Friday until 7:00 a.m. on Saturday. Please be observant of these times.**

BBQ CONTEST RULES:

1. Each category of the BBQ Contest entries will be judged in single round only. There will be no onsite judging, nor a final round judging.
2. For the BBQ event itself, cash prizes will be given to the top five finishers as follows: 1st Place - \$5,000.00, 2nd Place - \$2,500.00, 3rd Place - \$1,250.00, 4th Place \$500.00 and 5th Place \$250.00.
3. BBQ Contest blind judging containers will be delivered to each participant at the team's cook site at least 2 hours before turn-in. If you have not received a container, send a team member to see the Event Coordinator. When you bring your entry to the judging area, the containers shall contain only your entry - no garnish, just BBQ.
4. Anything placed in the container that identifies your team will cause your entry to not be scored. Cut your entries such that each judge will have their own portion. Provide sufficient samples for BBQ Contest judging by 8 judges.
5. BBQ Contest samples must be submitted to the turn-in table, located at the Admin area. We suggest that you familiarize yourselves with the location before judging time. All samples must be delivered as follows:

Butts - 9:50 a.m. and 10:10 a.m.

Judging will commence precisely on the hour. Any entry that arrives after the appointed turn-in time will not be scored. You will only be allowed to submit one entry per team for each category. After you turn in your entry, you must immediately leave the judging area.

6. As this is an SCBA Sanctioned Event, SCBA Judges will be used to judge this event. It is our belief that this will insure that each entry will be judged objectively based on the merits of the sample provided.
7. Once you have submitted your sample for judging, each Team will offer to the public an opportunity to sample your product. Samples shall consist of a tasting portion of pulled pork only – no sides or other products. The event will be selling BBQ Sampling Wristbands to the public. Admission to the cooking area will be only for those persons having purchased a wristband.
8. In the past, several of the teams have participated in a “Rib Throwdown,” organized and run by the competitors themselves and judged by the SCBA judges. It is expected that such a contest will once again take place at our event and we are committed to making the effort required to participate in the “Rib Throwdown” as rewarding as we can. Specific details will be announced closer to the actual date of the event.

It is first come, first served. Remember, your application is not complete until the full entry fee is received.

Experienced, trained and certified SCBA Judges will handle the judging in this contest. The winners will receive trophies and cash prizes.

Each team may provide their own shelter. Each team will be allocated one 20' x 25' outside space for their cooking area. **DUE TO THE LIMITED SIZE OF OUR AREA, IF YOU NEED MORE THAN A 20'X25' SPACE, YOU MUST LET US KNOW IN ORDER THAT WE CAN PLAN OUR SPACES ACCORDINGLY.** Parking for tow vehicles, trailers not used for cooking, etc., will be within a short walking distance of the cooking area. If you require a larger cooking area, please describe your reasons, including the sizes of grills, props and any other items used in your cooking set-up. You can use the space below, including the back of this form, or attach additional sheets if necessary. We value our barbeque cookers and we want to help you be successful.

In addition to the basic 20-amp service we added in 2016, we now have a limited number of higher amperage electrical service available – **AT AN ADDITIONAL COST.** There are three (3) 50-amp service outlets and six (6) 30-amp outlets available on a first come first served basis. In order to reserve one of these higher amperage outlets, you must request it at the time of application and pay an additional fee along with your entry. 30-amp service is an additional \$25.00 and 50-amp service is an additional \$50.00.

- Yes, I want to have 30-amp service and my additional \$25.00 is enclosed.
- Yes, I want to have 50-amp service and my additional \$50.00 is enclosed.
- No, 20-amp service is fine for my setup.

Each team's entry fee must be received with a completed application form no later than September 15, 2019. The cook-off committee reserves the right to reject any entry. If your entry is not accepted, your entry fee will be fully refunded. However, once you have been officially accepted into the contest, there will be no refunds of any portion of the entry fee.
